# **COLLEGE FEES & LEVIES**

St Mary's as a non-government school, does not receive sufficient grants from the Commonwealth and State governments to cover all running costs and is heavily reliant on families ensuring fees and levies are paid.

## **Capital Levy Discount**

Families with children also attending St Mary's Primary School will only pay one \$630 Capital Levy across both Schools. Each School invoices the Capital Levy separately with a split of \$262.50 invoiced by St Mary's Primary School and \$367.50 invoiced by St Mary's College.

All fees & levies must be up to date for a student to participate in any optional excursions or camps (e.g. Snow Trip, Overseas, and extracurricular sport) even if the travel costs are being met by themselves or other persons.

# **EXPLANATION OF LEVIES**

## **RESOURCE LEVY**

The Resource Levy covers consumable items used for subjects, excursions, school magazine most subject specific camps, pastoral care activities, St Mary's College/Fraser District and Wide Bay Trials for Athletics, Cross Country and Swimming Carnivals.

Some overnight subject camps may incur an extra minimal charge which is payable at the time of the camp.

The Resource Levy excludes any self-nominated activities e.g. Human Powered Vehicle Races, Snow Trip, Overseas trips, Graduation Dinner and sporting teams not listed above etc.

#### TECHNOLOGY LEVY

This levy supports the high level of information communication technology integration that the College now provides.

The levy will provide for and maintain our infrastructure – our high-volume broadband

link, wireless network, interactive projectors, hardware, student laptops, software and support of skilled personnel and services.

# **PAYMENT OPTIONS**

Statements are emailed at the start of each term. Payment of fees and levies can be made either ANNUALLY, PER TERM, MONTHLY or FORTNIGHTLY.

Via BPAY, credit card, direct debit, cash or cheque, EFTPOS.

For ongoing payment plans please contact our College Finance Secretary, Helen Reason on 4190 2200 (ext) 3. Helen will calculate your regular payment amount and assist in completing all paperwork.

For monthly or fortnightly credit card and direct debit payments please complete the relevant form and return to the College office. These forms are available on the Parent Portal or from our office.

#### SPLIT BILLING

Families who wish to split their account between two parents/guardians or third party must provide the College Finance Secretary with the relevant signed authority.

## <u>P & F LEVY</u>

This levy enables the P & F to acquire equipment and resources to benefit students.

#### YEAR LEVEL CAMPS

All year level camps are compulsory. Approval for non-attendance and refunds must be sought by written application to the Principal.

Information and relevant forms regarding your child's camp or excursion will be emailed home as they arise.

#### **CAPITAL LEVY**

The compulsory Capital Levy of \$630 per family ensures the College can continue building and maintaining facilities designed to optimise the learning environment for every student.

#### PARISH CONTRIBUTION

A contribution of \$10 per term is included on your term statement should you like to contribute to the support of St Mary's Parish. This is a voluntary payment only.

#### **CONCESSIONS**

St Mary's College is committed to providing a Catholic education to all children whose parents desire it. We are also aware that some parents find themselves in financial difficulties from time to time. We have formalised a system of fee concessions which are available on application to any parent of an enrolled student. Fee concessions are determined on a means-tested basis.

Concessions are only granted on Fees. All levies and camps must be paid in full.

Fee Concession cannot be offered for/ with participation in the music program, overseas trip or snow trip.

Parents who find themselves in this situation should discuss this matter with the College Business Manager, Mrs Desley Lourigan and request an Application for Concessional Fees.
